# COMMEMORATION OFALL THE FAITHFUL DEPARTED (ALL SOULS DAY) Saturday, 2 November 2013

The Rite of Marriage during Mass cannot be celebrated on All Souls Day. However, it is possible to celebrate the Rite of Marriage outside Mass on All Souls Day.

#### BLESSINGS RELATED TO ADVENT AND CHRISTMAS

The rite for the blessing of an Advent Wreath, a Manger or Nativity Scene, a Christmas Tree, and of homes during the Christmas season, are found in the *Book of Blessings*. The introductions to these various blessings offer helpful pastoral and liturgical information. The provided blessings for an Advent Wreath and a Manger or Nativity Scene maintain an important balance and perspective with regard to these elements of devotion and the celebration of the Sacred Liturgy.

#### COLDS AND FLU

#### AND THE CELEBRATION OF THE SACRED LITURGY

- Ministers of Holy Communion should wash their hands before Mass begins, or even use an alcohol based anti-bacterial solution in the pew before distributing, and after purifying their fingers after the distributing Holy Communion;
- ❖ People feeling ill should avoid receiving Communion from the chalice.

Priests are encouraged to use good pastoral common sense to allay the fears of the faithful during cold and flu season. An example of this might include refraining from the use of the Sign of Peace during the celebration of Mass and reminding the faithful not to receive the Precious Blood if they are ill.

### EXTRAORDINARY MINISTERS OF HOLY COMMUNION

- All Extraordinary Ministers of Holy Communion are to have an appointment letter from the Archbishop.
- Pastors and chaplains are encouraged to send new Extraordinary Ministers of Holy Communion to the archdiocesan formation sessions. Current Extraordinary Ministers of Holy Communion are also welcome to these sessions.
- Pastors and chaplains are reminded to inform the Office for Divine Worship if they conduct their own formation and to send to this office their request for new Extraordinary Ministers of Holy Communion.
- Request forms can be found on the Office for Divine Worship website. Letters of Appointment from the Archbishop will then follow.

- Extraordinary Ministers of Holy Communion are appointed for a three-year term and for the place where they are commissioned. Terms may be renewed if agreeable to both the pastor/chaplain and the minister.
- Pastors are reminded to conduct the commissioning of new Extraordinary Ministers of Holy Communion according to the rite found in the <u>Book of Blessings</u>, Chapter 63.

#### Important Notice for Pastors:

Under no circumstances are consecrated hosts to be reserved in peoples' homes during the day or overnight for the Communion of the Sick. Every possible arrangement is to be made that hosts for the Communion of the Sick are to be given to the Extraordinary Minister of Holy Communion during the Communion of the Mass. If this is not possible, and with very good reason, then arrangements are to be made for the hosts to be obtained outside of Mass so that the Communion minister can then go immediately to the sick.
