## FEAST OF THE PRESENTATION OF THE LORD Thursday February 2, 2017

The Blessing of Candles using one of the two forms in the *Roman Missal* should be scheduled to take place at one of the parish Masses.

## WORLD DAY FOR CONSECRATED LIFE Thursday, February 2, 2017 (Celebrated February 4-5, 2017)

World Day for Consecrated Life is a day of prayer for women and men who make public vows to "imitate Christ more closely, striving for the perfection of charity in the service of the Kingdom of God." (*Code of Canon Law, canon 573*). World Day for Consecrated Life is observed by the universal Church on February 2; however, in the United States in order for parishes to fully celebrate this important day, it is transferred to the following Sunday.

All priests are welcome to concelebrate the Sunday, February 5, 2017, 6:30 PM Mass at the Cathedral Basilica to observe the World Day for Consecrated Life. Archbishop Charles Chaput will be the celebrant and homilist. Confessions will be heard beginning at 5:30 PM.

## **BLESSING OF THROATS**

#### Friday, February 3, 2017

The blessing of throats should be observed according to the directives and with the prayer found in the *Book of Blessings*, Chapter 51. It is also possible for the blessing of throats to follow the celebration of Mass.

## MEMORIAL OF SAINT JOSEPHINE BAKHITA NATIONAL DAY OF PRAYER FOR SURVIVORS AND VICTIMS OF HUMAN TRAFFICKING Wednesday, February 8, 2017

# MEMORIAL OF OUR LADY OF LOURDES AND PRAYER FOR THE SICK Saturday, February 11, 2017

Blessed Pope John Paul II in 1992 established *World Day of the Sick* in conjunction with the Memorial of Our Lady of Lourdes. A remembrance of the sick in the announcements and in the Universal Prayer is especially fitting this day.

#### LENT, THE SACRED PASCHAL TRIDUUM AND EASTER TIME

#### ASH WEDNESDAY

#### Wednesday, March 1, 2017

Ashes are distributed **only** on Ash Wednesday and **not** the days before or after. The directives and texts in the *Roman Missal* are to be faithfully observed. In other words, to distribute blessed Ashes without some announcement of God's Word seriously compromises the meaning of the sacramental. When ashes are provided for the homebound, they should be carefully packaged in an appropriate container and not in a tissue. Also, a form for imposition should be provided, modeled on the *Roman Missal's* instructions for the distribution of blessed ashes outside Mass.

#### CONFESSIONS DURING LENT

Parish resources to promote a better understanding and preparation for the celebration of the Sacrament of Penance and Reconciliation can be found on the website for the Office for Divine Worship.

Please see the Memo contained in this Monthly Mailing regarding additional times for Confessions during Lent and the observance of 24 Hours for Lord prior to the Fourth Sunday of Lent.

#### WAY OF THE CROSS AND BENEDICTION OF THE MOST BLESSED SACRAMENT

Typically, the Way of the Cross, with the movement from station to station, does not take place in conjunction with exposition and benediction of the Most Blessed Sacrament. Exposition with the reading of the Word of God and time for adoration and then Benediction may follow the Way of the Cross.

#### **VEILING OF STATUES**

In the dioceses of the United States, crosses in the church may be covered from the conclusion of the Mass for the Saturday of the Fourth Week of Lent until the end of the Celebration of the Lord's Passion on Good Friday. Statues in the church may be covered from the conclusion of the Mass for Saturday of the Fourth Week of Lent until the beginning of the Easter Vigil. #### Additional Information for Liturgical Preparation

The *Circular Letter Concerning the Preparation and Celebration of the Easter Feasts (Paschale Solemnitatis),* by the Congregation for Divine Worship, January 16, 1988, is posted on the website for the Office for Divine Worship. This letter provides helpful pastoral,

theological and liturgical (as well as liturgical music) information for pastors and preparers of the Sacred Liturgy for Lent, the Sacred Paschal Triduum and Easter Time.

## RITE OF ELECTION AND CALL TO CONTINUING CONVERSION Cathedral Basilica of Saints Peter and Paul, Philadelphia PA First Sunday of Lent, 2017

Saturday, March 4, 2017 at 11:00 AM for Montgomery and Philadelphia South Saturday, March 4, 2017 at 3:00 PM for Chester and Philadelphia North Sunday, March 5, 2017 at 3:00 PM for Bucks and Delaware

- All correspondence and registration will be conducted electronically. See the website for the Office for Divine Worship.
- The Call to Continuing Conversion is meant for adults (and not children) who are baptized and will be received into Full Communion and/or Confirmation and/or Communion. Also, the Call to Continuing Conversion is equally meant for those already baptized who have not been practicing the Christian Faith but now are returning with the celebration of the Easter Sacraments.
- Parishes are encouraged to observe the *Sending of Catechumens for Election* (cf. RCIA, nos. 106-117) or the *Rite of Sending the Candidates for Recognition by the Bishop and for the Call to Continuing Conversion* (cf. RCIA, nos. 434-445) or the *Parish Celebration for Sending Catechumens for Election and Candidates for Recognition by the Bishop* (cf. RCIA, nos. 530-546), depending on the local circumstances, the week or so before the *Celebration of the Rite of Election of Catechumens and of the Call to Continuing Conversion of Candidates.*

#### IMPORTANT INFORMATION FOR THE EASTER VIGIL

#### Time of the Easter Vigil

The Easter Vigil should not begin before nightfall. It may be helpful to know that sunset, according to the US Naval Observatory Astronomical Applications Department, occurs at 7:39 PM on April 15, 2017.

In accord with the US National Statutes for the Catechumenate (November, 11, 1986) no. 33, Archbishop Chaput asks that you note:

<u>Only</u> the adult elect, that is, the unbaptized catechumens elected at the Rite of Election, are to be fully initiated with Baptism, Confirmation and reception of the Body and Blood of the Lord at the Solemn Paschal Vigil, according to the rites outlined in the *Roman Missal*. Children may also be baptized at the Easter Vigil.

Baptized non-Catholic Christians are to be received into the Full Communion of the Catholic Church on Palm Sunday or Easter Sunday or any Sunday of Easter Time. In fact, this reception can take place almost any time during the Church Year according to the rite outlined in the *Rite of Christian Initiation of Adults* (cf. RCIA, nos. 473-504). No additional permission is required for this Reception of Baptized Christians in the Full Communion of the Catholic Church.

For many parishes, this practice continues to represent an innovation that requires catechesis on the dignity of Baptism and the avoidance of any confusion between candidates for Baptism and baptized Christians.

Candidates for the Reception into the Full Communion of the Catholic Church should be encouraged to participate in the Easter Vigil, especially with a distinct place to sit among the faithful and acknowledged by the priest celebrant.

# RECEPTION OF BAPTIZED CHRISTIANS INTO THE FULL COMMUNION OF THE CATHOLIC CHURCH

The *Rite of Christian Initiation of Adults* allows for people baptized in another Church or ecclesial community, although never treated as catechumens, to benefit from the doctrinal and spiritual formation of the unbaptized. Additionally, the use of the Combined Rites for catechumens and candidates gives the candidates an important sense of the Sacred Liturgy and participation with the Church leading to Confirmation and Communion. However, many candidates do not require a full program parallel to the catechumenate. Therefore, the directives provided in the US National Statutes for the Catechumenate for Reception into Full Communion (nos. 30-37) should be increasingly observed.

Preparation and celebration of the Sacrament of Penance and Reconciliation for baptized non-Catholics are an essential element of their Reception (See RCIA, no. 482).

#### **Reception of Candidates and Valid Baptism and Conditional Baptism**

All non-Catholic Christians seeking full communion must be validly baptized. The following norm is to be observed in the Archdiocese of Philadelphia with regard to the reception of candidates into the full communion of the Catholic Church:

Baptism is the doorway to all of the Sacraments. Therefore, the sacred minister needs moral certitude that a person was baptized with the Trinitarian formula and the triple water pouring/immersion before other Sacraments are celebrated. This moral certitude requires more than the evidence of a baptismal certificate and must be the case in each individual circumstance. Such moral certitude can often be readily obtained through inquiry with the candidate. When moral certitude is lacking, a conditional Baptism is necessary (see Canon 869 and National Statutes for the Catechumenate 37).

#### CONFIRMATION FOR ROMAN CATHOLIC ADULTS

The ordinary minister of the Sacrament of Confirmation for baptized Roman Catholics is the Bishop. Typically, this occurs during the pastoral visit of the Bishop to the parish. <u>Every effort</u> should be made to prepare Catholic Adults for Confirmation to participate in the parish celebration with the Bishop.

Additionally, Archbishop Chaput will celebrate the Sacrament of Confirmation on Pentecost Sunday, June 4, 2017, during the 6:30 PM Mass at the Cathedral Basilica of Saints Peter and Paul. The candidates for this sacramental celebration are baptized Roman Catholics who have been properly catechized for Confirmation (and if needed, for the reception of First Communion). Information about this celebration for pastors and those who assist with the formation and reception of the Sacraments of Initiation will be distributed by e-mail in February 2017 to all parish Liturgy Contacts, parish Christian Initiation Coordinators, and DRE's, and can also be found on the website of the Office for Divine Worship.

If for some serious reason, a school age baptized Roman Catholic is unable to be confirmed by the Bishop during his pastoral visit to the parish, then this candidate, with the permission of the pastor, may be presented for the Sacrament of Confirmation on Pentecost Sunday. The pastor's permission is to be included with the registration forms to be sent to the Office for Divine Worship.

A pastor who foresees the genuine pastoral need to confirm an adult baptized Roman Catholic can do so only with the specific delegation of the Bishop (see Canon 882 and *National Statutes for the Catechumenate,* nos. 28-29). Archbishop Chaput gives this faculty to all priests of the Archdiocese to confirm Roman Catholic Adults on any occasion from Palm Sunday through Pentecost Sunday. This delegation is required for the validity of the Sacrament in the case of a Roman Catholic candidate. If you have any questions about this faculty, please contact the Office for Divine Worship. There is no need for an additional letter requesting this faculty during the period specified by the Archbishop. Priests are reminded that only the 2016 revised *The Order of Confirmation* may be used to celebrate the Sacrament.

# COLDS AND FLU AND THE CELEBRATION OF THE SACRED LITURGY

- Ministers of Holy Communion should wash their hands before Mass begins, or even use an alcohol based anti-bacterial solution in the pew before distributing, and after purifying their fingers after the distributing Holy Communion;
- People feeling ill should avoid receiving Communion from the chalice.

Priests are encouraged to use good pastoral common sense to allay the fears of the faithful during cold and flu season. An example of this might include refraining from the use of the Sign of Peace during the celebration of Mass and reminding the faithful not to receive the Precious Blood if they are ill.

# EXTRAORDINARY MINISTERS OF HOLY COMMUNION

# All Extraordinary Ministers of Holy Communion are to have an appointment letter from the Archbishop.

• Candidates are to be fully initiated practicing Catholics, high school graduates, validly married (if married), recognized for faith and devotion to the Holy Eucharist as well as for service in the parish/institution.

Pastors and chaplains are encouraged to send new Extraordinary Ministers of Holy Communion to the archdiocesan formation sessions. Current Extraordinary Ministers of Holy Communion are also welcome to attend. Here, you can find already scheduled workshops to attend:

Extraordinary Ministers of Holy Communion Workshops

- Extraordinary Ministers of Holy Communion typically serve for three years. Pastors/chaplains may renew terms, if agreeable and in consultation with the minister.
- Pastors and chaplains are reminded to inform the Office for Divine Worship if they conduct their own formation and to send to this office their request for new Extraordinary Ministers of Holy Communion.
- Request forms can be found on the Office for Divine Worship website. Letters of Appointment from the Archbishop will then follow.
- Extraordinary Ministers of Holy Communion are appointed for a three-year term and for the place where they are commissioned. Terms may be renewed if agreeable to both the pastor/chaplain and the minister.
- All records of active Extraordinary Ministers of Holy Communion are maintained by the parish/institution.
- Extraordinary Ministers of Holy Communion are commissioned after participation in a training session, according to the form found in the Book of Blessings, Chapter 63, "Order for the Commissioning of Extraordinary Ministers of Holy Communion."
- Extraordinary Ministers of Holy Communion only serve in the parishes/institutions for which they are commissioned.

#### OTHER POINTS

Below are responses to inquiries to the Office for Divine Worship:

## The Gloria is sung at all weekday Wedding Masses during Lent

With the introduction of the third edition of the *Roman Missal* the Gloria is sung, even during Advent and Lent, when the Ritual Mass for the Celebration of Marriage is used. The Penitential Act is always omitted during a Wedding Mass. Priests and deacons are reminded

that only the 2016 new ritual book, *The Order of Celebrating Matrimony* may be used for the celebration of the Sacrament.

Full Initiation—Baptism, Confirmation and the first reception of Communion—apart from the Easter Vigil, outside the immediate danger of death, requires the permission of the Archbishop (see RCIA, no. 331). Archbishop Chaput delegates the Office for Divine Worship to give this permission. Please contact the Office for Divine Worship for such circumstances.

# Read about our individual choirs:

**Cathedral Choir:** This is a select group of liturgical musicians who sing each and every Sunday here at the Cathedral, mainly for the 11:00am Solemn Mass (with a monthly 9:30am Mass) along with all special events and Archdiocesan events. Vocal training and an advanced knowledge of music with specific regards to sight-singing is a must. We are currently looking for Volunteers, One Soprano Section Leader, One Tenor Section Leader, and One Alto Section Leader. The repertoire that we sing spans the centuries from Gregorian chant to Bruckner to Eric Whitacre. What a rewarding experience it is to make music in such a beautiful place!

**Archdiocesan Adult Choir:** This choir is comprised mainly of music directors throughout the Archdiocese of Philadelphia, and some of their best singers! The commitment for this choir is not as intense as the Cathedral choir, as the Archdiocesan choir sings only for Archdiocesan Events including Ordinations, Chrism Mass and few select concerts throughout the year. The rehearsals are 2 Mondays a month. Vocal training and sight-reading are a must. There is not enough time in rehearsals to feed notes, so there is outside preparation expected on the part of each individual selected for this choir.

**Archdiocesan Boys and Girls Choir:** Our select children from the Archdiocese sing once a month at the Cathedral Basilica of Saints Peter and Paul at the 5:15 PM Anticipated Mass and for various Archdiocesan Events throughout the year. In this choir, the basics of music theory are touched upon with emphasis on note-reading, counting, solfeggio and a general concept of how to appropriately perform liturgical music. It's a wonderful opportunity for all ages, as the group has a varied range of abilities and experience. The age range for this group is 3rd grade to 12th grade.

# Less is More

As prescribed in the *General Instruction of the Roman Missal*, the use of the organ and other instruments should be "with a moderation that is consistent with the season's character" and used "to support the singing" of the Assembly during Lent. During this time the parishioners will continue to participate in the sung parts of the Mass, but it is suggested that simpler settings be used during this time. Over the past few years, parishes have been incorporating more chant into the menu of what our congregation is being fed. This season is a wonderful time to experience the solidarity of unison chant singing, with the very bare quality of accompaniment that comes along with it. The "Less is More" idea can be brought to life for our people in the pews as they enter into this season of reflection and conversion in preparation for Easter.

During Lent, singing the <u>traditional chant Mass</u> in Latin or English can help our congregations to enter more deeply into the Paschal Mystery. An additional option for a simpler Mass setting would include the "Missa Simplex" by Richard Proulx. Another way of incorporating this sense of less is more is <u>to chant the Lenten Gospel Acclamation</u>. There is a beautiful chant from the "Kyrie Orbis Factor" by Bob Hurd which can accompany any of the above mentioned Mass settings very nicely.

To quote Richard Gibala, "During Lent, perhaps less is more. But more is also more: Less music, more silence." To give people the space to allow the Lord to enter in and fully receive his grace would be a very attainable goal for us – the leaders of sung prayer. Let's make it our job to incorporate simplicity and solemnity to this season, so that when Easter Sunday arrives, the joyous season of Easter may be truly received.
