## SOLEMNITY OF MARY, THE HOLY MOTHER OF GOD

Monday, January 1, 2024

The Solemnity of Mary, the Holy Mother of God is not observed as a Holy Day of Obligation this year since it falls on a Monday.

The liturgical observance of a Solemnity typically begins the evening before with Evening Prayer I. The celebration of the Eucharist on the evening before would be the proper Vigil Mass of the Solemnity or, if there is no proper Vigil Mass, the Anticipated Mass.

Since the Solemnity of Mary, the Holy Mother of God is not a day of obligation this year and the day before is a day of obligation, Sunday, the day of obligation takes precedence for the evening Mass. So, the Parish Sunday evening Mass on December 31, 2023 may be of the Sunday and for the Sunday with the Mass for the Feast of the Holy Family of Jesus, Mary and Joseph. Evening Prayer would be Evening Prayer I of the Solemnity of Mary, the Holy Mother of God.

## FEAST OF SAINT JOHN NEUMANN

### Friday, January 5, 2024

The commemoration of Saint John Neumann enjoys the rank of a *feast* in the Archdiocese of Philadelphia for both the celebration of Mass and the Divine Office. Therefore, both at Mass and for the Liturgy of the Hours those features proper to a *feast* are observed.

#### WEEK OF PRAYER FOR CHRISTIAN UNITY

## Thursday, January 18, 2024 through Thursday, January 25, 2024

The Week of Prayer for Christian Unity should have, if possible, intentions in the Universal Prayer. Also, when possible during this week the Mass for the Unity of Christians may be used with the readings of the day and green vestments.

# THIRD SUNDAY IN ORDINARY TIME SUNDAY OF THE WORD OF GOD

Pope Francis' Apostolic Letter, *Motu proprio* "Aperuit illis", published on September 30, 2019 established that "the Third Sunday in Ordinary Time is to be devoted to the celebration, study and dissemination of the Word of God".

#### **SPECIAL DAY OF PRAYER**

#### FOR THE DIOCESES OF THE UNITED STATES OF AMERICA

### Monday, January 22, 2024

In all the Dioceses of the United States of America, January 22 (or January 23, when January 22 falls on a Sunday) shall be observed as a particular day of prayer for the full restoration of the legal guarantee of the right to life and of penance for violations to the dignity of the human person committed through acts of abortion. The liturgical celebrations for this day may be the Mass "For Giving Thanks to God for the Gift of

Human Life" (no. 48/1 of the Masses and Prayers for Various Needs and Occasions), celebrated with white vestments, or the Mass "For the Preservation of Peace and Justice" (no. 30 of the Masses and Prayers for Various Needs and Occasions), celebrated with violet vestments.

#### COLDS AND FLU

### AND THE CELEBRATION OF THE SACRED LITURGY

- Ministers of Holy Communion should wash their hands before Mass begins, or even use an alcohol based anti-bacterial solution in the pew before distributing, and after purifying their fingers after the distribution of Holy Communion;
- ❖ People feeling ill should avoid receiving Communion from the chalice.

Priests are encouraged to use good pastoral common sense to allay the fears of the faithful during cold and flu season. An example of this might include refraining from the use of the Sign of Peace during the celebration of Mass and reminding the faithful not to receive the Precious Blood if they are ill.

The Office for Divine Worship has the responsibility for direction, guidance and support of pastors and those who collaborate with them in the formation of adults for Christian Initiation. The Call to Continuing Conversion is meant for adults (and not children) who are baptized and will be received into Full Communion and/or Confirmation and/or Communion. Also, the Call to Continuing Conversion is equally meant for those already baptized who have not been practicing the Christian Faith but now are returning with the celebration of the Easter Sacraments.

#### PLEASE NOTE

Full Sacramental Initiation—Baptism, Confirmation and the first Reception of Holy Communion—apart from the Easter Vigil, outside of the immediate danger of death, requires the permission of the Archbishop (see RCIA, no. 331) for someone 14 years of age or older. Archbishop Perez delegates the Office for Divine Worship to give this permission. Please contact the Office for Divine Worship for such circumstances.

## EXTRAORDINARY MINISTERS OF HOLY COMMUNION

- All Extraordinary Ministers of Holy Communion, without exception, are to have a current appointment letter from the Archbishop.
- Extraordinary Ministers who serve in institutions and schools throughout the Archdiocese are typically commissioned for service in their parishes and likewise commissioned for service in the institution and/or school.
- Candidates are to be fully initiated practicing Catholics, high school graduates, not
  in an invalid marriage, recognized for faith and devotion to the Holy Eucharist as
  well as for service in the parish/institution/school. Pastors/chaplains are reminded
  to be discerning in the invitation to members of the lay faithful to carry out this
  ministry.
- Pastors and chaplains are encouraged to send new Extraordinary Ministers of Holy Communion to the archdiocesan formation sessions. Letters of Appointment from the Archbishop will then follow. *Veteran Extraordinary Ministers of Holy Communion are also welcome to attend.*
- Pastors and chaplains are reminded to inform the Office for Divine Worship if they
  conduct their own formation and to send to this office their request for new
  Extraordinary Ministers of Holy Communion. Request forms can be found on the
  Office for Divine Worship website. Letters of Appointment from the Archbishop
  will then follow.
- Extraordinary Ministers of Holy Communion are appointed for a three-year term and for the place where they are commissioned. Terms may be renewed if agreeable to both the pastor/chaplain and the Extraordinary Minister of Holy Communion.
- All records of active Extraordinary Ministers of Holy Communion are maintained by the parish/institution/school.
- Extraordinary Ministers of Holy Communion are commissioned after participation in a training session, according to the form found in the *Book of Blessings*, Chapter 63, "Order for the Commissioning of Extraordinary Ministers of Holy Communion."

• Extraordinary Ministers of Holy Communion only serve in the parishes/institutions/schools for which they are commissioned.

#### RECURRING INFORMATION

#### THE PRAYER TO SAINT MICHAEL, THE ARCHANGEL

Many parishes and institutions within the Archdiocese have responded positively to pray the prayer to Saint Michael in conjunction with the celebration of Mass. You are reminded that this devotional prayer is to take place outside of Mass. It is not to be prayed as the concluding prayer of the Universal Prayer nor as part of the Communion Rite.

#### TIME FOR VIGIL MASSES AND ANTICIPATED MASSES

The time for Vigil Masses and Anticipated Masses in the Archdiocese of Philadelphia is no earlier than 4:00 PM. This applies to Holy Days of Obligation as well, including Christmas.

# THE MASS SCHEDULE FOR HOLY DAYS WHEN THE OBLIGATION IS SUSPENDED

In the United States, there are three Holy Days, Solemnities, when the obligation to participate in Mass is suspended when the observance falls on a Monday or a Saturday—the Solemnity of Mary, the Holy Mother of God (January 1), the Solemnity of the Assumption of the Blessed Virgin Mary (August 15), and the Solemnity of All Saints (November 1). In these instances, the Mass schedule certainly can be modified. However, there should be the celebration of one Mass at least for the benefit of the faithful who desire to attend Mass.

## TIME OF THE EASTER VIGIL 2024

The Easter Vigil is the first Mass of Easter Sunday and not in any way to be considered an Anticipated Mass for Easter Sunday. This is why the discipline of the Church insists that it should not begin before nightfall in any circumstance. It may be helpful to know that sunset, according to a variety of models, occurs approximately at 7:23 PM on March 30, 2024. This information is provided at this time to assist with calendar planning for 2023-2024. In general, given the variable date for Easter, it seems best to schedule the Easter Vigil each year for 8:00 PM or later.
